CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CALVIN AND MARIECA HAIGHT
15715 WEST PERRYDALE ROAD
AMITY, OREGON 97101

confirms the right to use the waters of AN UNNAMED INTERMITTENT STREAM AND HAIGHT RESERVOIR CONSTRUCTED UNDER PERMIT R-7696, a tributary of SOUTH YAMHILL RIVER, for the purpose of IRRIGATING 38.8 ACRES AND LIVESTOCK.

The right has been perfected under Permit 43448. The date of priority is AUGUST 3, 1978. The right is limited to not more than 0.49 CUBIC FOOT PER SECOND; BEING 0.485 CFS FOR IRRIGATION AND 0.005 CFS FOR LIVESTOCK or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 73, SECTION 18,
T 6 S, R 5 W, W.M.; 1300 FEET NORTH AND 140 FEET WEST FROM SE CORNER
DLC 73.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

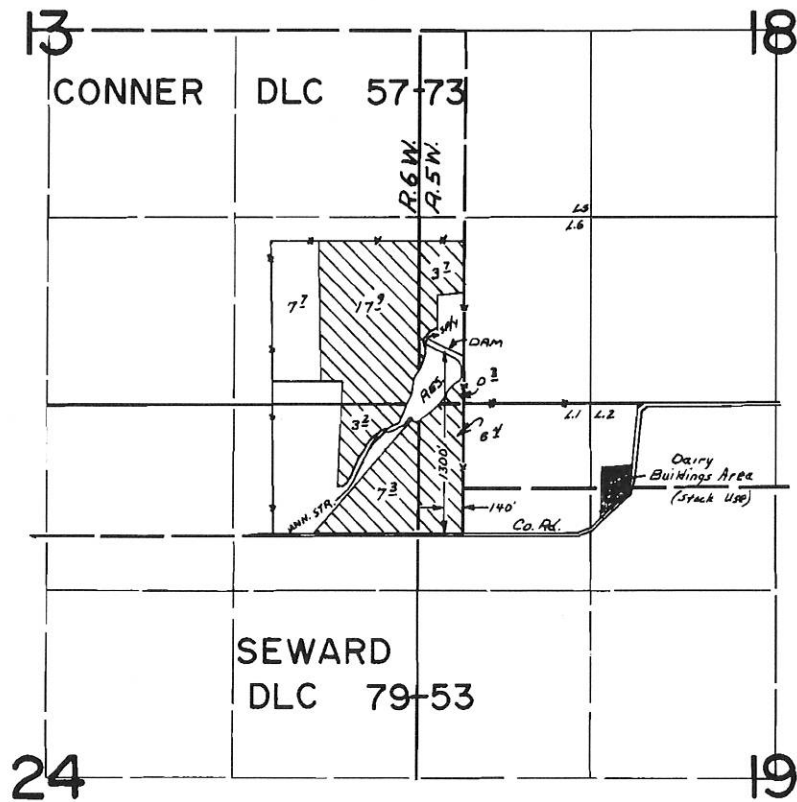
